**EPC Office:** The EPC office is located at 303 Corporate Center Drive, Suite 208 in Vandalia.

**From I-75** take exit 63. Turn west on US 40 toward Vandalia. Turn left on Corporate Center Drive (immediately after Airport Toyota).

**From I-70** take exit 32. Turn right on US 40. Turn right at the first light, Peters Pike. Turn left on World Wide Dr, 2<sup>nd</sup> driveway entrance on left.

**Aullwood Audubon Center:** Aullwood is located at 1000 Aullwood Road in Dayton.

**From I-70** take exit 29 for OH 48 toward Dayton/Englewood. Turn Right on S. Main/OH 48. Turn right at National Road. Turn right on Aullwood Road.

**From I-75** merge onto I-70W then follow directions above.
